Karen Sheek introduces Lt. Gov. Dianne Primavera

- Lt. Gov. Primavera described crisscrossing the state with Gov. Polis while campaigning and the doubt they received
- She noted the strong progress achieved by the current gubernatorial administration in reducing costs for Colorado's families in healthcare,
- She told of her struggles 34 years ago as a single mother with breast cancer

Nominating Slate Adoption

LWVCO Nominating Chair Connie Fox made a motion that the secretary cast a unanimous ballot for the slate as presented in the Annual Meeting Workbook. Because the motion came from a committee, no second was needed. The motion passed unanimously.

President Karen Sheek explained that LWVCO Bylaws state that the Nominating Committee is made up of five people: three non-Board members; and two Board members. Lena Brown of the LWVCO Board and LWV Arapahoe Douglas will chair this year, and the Board will appoint the 2nd member at our first Board meeting. The three non-Board members serving on the Nominating Committee, Connie Fox (LWV Montezuma), Marjie Gray (LWV Chaffee County), and Vicky McLane (LWV Larimer), each have a year remaining in their terms, so new elections are not needed.

President Karen Sheek then recognized three outgoing Board members: Dr. Connie Fox, Dr. Beth Malmskog, and Dr. Toni Larson. A video for Toni made by former SOS Bernie Buescher was shared.
