Mental Health Colorado honored Barbara Mattison as Individual Honoree of the Year for her 'extraordinary leadership in identifying the gaps in Colorado's mental health system, rallying statewide support for reform, and bringing national attention to the cause' based on her related work with the League of Women Voters and with Colorado CASA.

Her recognition continues: 'In 2013 as president of LWVCO, she convened and chaired the League's Behavioral Health Task Force, directed a statewide effort to analyze current practices in the prevention and treatment of mental health and substance use disorders, and led the charge not only to adopt a comprehensive platform for Colorado but also to make that platform a priority for the League of Women Voters of the United States.

'From 1997 to 2004, Barbara served as executive director of Colorado CASA, the state coordinating body for Court Appointed Special Advocates. She strengthened CASA's advocacy work, developed new CASA agencies, and helped provide critical training and support to 600 volunteers across the state. Thanks in large measure to Barbara's leadership, CASA now benefits more than 2,000 abused and neglected children each year.

Several LWVCO board members joined Barbara and her husband at the Tribute dinner at a table sponsored by Bobbie Heisterkamp.

BREAKING NEWS! LWVCO APPROVED FOR VOTER REGISTRATION AT NATURALIZATION CEREMONIES

This exciting news broadens one of League's core roles: voter registration. This also fulfills one aspect of LWVCO's 2016-17 *Making Democracy Work* goal.

USCIS has sent guidelines for organizations that do voter registration at naturalization ceremonies. A USCIS supervisor will contact us soon to begin our training. A committee of representatives from several Colorado Leagues has been formed and will be involved in moving this work forward.

Mabel Costigan, class of 1892 at Denver's East High was inducted into East High's Alumni Heritage Hall of Fame in September, 2016. The tribute in the *Spotlight*, the newsletter of the East Angel Friends & Alumni Foundation, reads 'she married her East High classmate Edward Costigan [who became a U.S. Senator] and became a leading national women's rights advocate. In 1928, she founded Colorado League of Women Voters and was its first president [serving through 1930]'.

LOCAL LEAGUE VOTER SERVICE **ACCOMPLISHMENTS**

By Sue Vaughan, LWVCO 3rd VP, Local League Support As an overview, 14 of 19 local Leagues conducted voter registration, 12 of 19 held candidate forums or meet and greets, and 16 of 19 presented ballot issue forums. Boulder County and Pueblo conducted voter registration at local high schools: Estes Park and Montrose County sponsored junior elections in the schools; and La Plata County was asked to offer expertise to the seventh and eighth graders as they were preparing a symposium to include issues and candidates along with information about political parties for the students and the public. Adams County was asked by the Northglenn High School U.S. Government Class to judge some voter registration projects developed by this class for the general election.

Many Leagues reached out to diverse groups, such as Latino and African American voters, ARC, homeless veterans, food banks, and a behavioral health center. Greeley-Weld conducted a successful voter registration with Americorps. Archuleta County and Mesa County videotaped forums, which are available on their websites. In Estes Park, a candidate forum for two Larimer County Commission vacancies streamed live over a local TV station and was recorded for a later viewing. La Plata County had four League members at the City Council Chambers presenting the statewide ballot issues, which were taped and made available on the community access

channel as well as being streamed on the Durango City Government site. While there were many creative events, a couple to highlight included a very successful Chaffee County Candi-date Event, patterned after speed-dating as a format to meet candidates, and the La Plata League, along with the Durango Herald, co-hosted an election night party which was open to the public. Also of note are the many collaborations local Leagues formed to cosponsor candidate and ballot issue forums.

The LWVCO Board Liaisons collected this information on the ambitious voter service work of the local Leagues. All have been extremely busy and visible in their communities. Liaisons did not collect data on the number of candidate forums, ballot issue forums, or voter registrations although some Leagues reported this. The talking points did not request information about cosponsoring events, though some Leagues reported this information. In addition, data was not collected on the outreach to diverse groups or if new members joined as a result of voter service events, but some Leagues reported this information. In the future, it would be beneficial for the liaisons to solicit more data as part of the LWVCO Liaison talking point related to voter service.

Kudos to each local League for their tireless and productive voter service work. Sue Vaughan, LWVCO VP, will send a table via email with more detailed information to the local League Presidents and State Contacts. Great work everyone!

LOCAL LEAGUES RECEIVE PROJECT FUND AND EZ GRANTS

The LWV of Colorado is pleased to announce grants awarded to four local Leagues in August 2016. We look forward to their written reports by April 2017, detailing the outcome of their projects.

Project Fund Grants:

- LWV of Boulder County, \$1,075, to focus on voter education and membership: six or seven table fees at community events to attract people from nontraditional groups; materials promoting "community conversations"; and to provide speakers on League topics to the general public.
- LWV of Pueblo County, \$1,500, to focus on voter education and to strengthen the local League by developing information and communication technology (ICT). The League will contract a local social media and digital marketing expert to produce a new integrated communication platform to expand the League message to current and potential members, including younger voters. The League will match the grant funds received from LWVCO.

EZ Grants:

- LWV of Mesa County, \$500, to pay half the cost of \$1,000, to print in color, four VOTE 411 advertisements in *The Daily Sentinel*. The League has secured an additional \$500 from a local bank to fund their fall programming.
- LWV of Montezuma County, \$300, for a Great Decisions project, to purchase materials (DVDs and briefing books) for the Mancos and Dolores groups.

LWVCO 501(c)(4) to 501 (c)(3) CONVERSION UPDATE

The work of the 501 Task Force to streamline LWVCO structure and processes continues. The Task Force has identified all the documents and processes that need to be addressed and possibly changed and is currently working on revisions that will be needed in the Articles of Incorporation and the Bylaws, should we decide to go forward with the conversion. These changes and the entire process will be reviewed at the next LWVCO Board Meeting on December 8. The LWVCO Board will decide whether to recommend the conversion to the entire LWVCO membership at its January 12 meeting.

If the Board approves, a final packet of explanatory materials will be prepared in January to be sent to all Leagues for their review before the LWVCO Convention in May. This significant change will need to be approved by the Convention delegates before the actual conversion can occur. The main purpose of the conversion is to simplify and streamline the activities of the state League and to eliminate duplication of effort. The resulting 'League of Women Voters of Colorado' will be a single consolidated 501(c)(3) charitable nonprofit organization, which can spend up to 20% of its budget on advocacy.

The Google AdGrant can help drive awareness to our mission, help attract donations and possibly recruit members and volunteers. AdGrant advertising will help drive more traffic to our State League website and bring about more engagement from people searching for an organization like LWVCO.

Our AdGrant advertising will first focus on directing searches to completing the VOTE411 information box on our website homepage. After the election, our ad will be changed to the theme of "Making Democracy Work" and be devoted to increasing the public's interest in LWVCO.

TWO LEAGUE LEADERS WILL BE MISSED!

This fall the League lost two former LWVCO board members: Jean Swartzendruber, who served as 2nd VP in the late 90s/early 2000s, and Marlene Wiske, who served on the board in 1974 and was LWVCO president from 1975-1977. Jean, a long time member of the Pikes Peak League, served as president and most recently as an active voter service chair. She passed away in August. Marlene, who was a member and past president of the Adams County League, passed away on October 31.

HOW IS VOTE411 DOING?

Was VOTE411.org successful? Did candidates participate and did voters use the site to get unbiased voting information? The answer to both is YES. Several strategies were used to increase candidate participation: 1) State Party chairs were contacted by e-mail in August explaining VOTE411, the benefits to candidates when participating, and asking them to encourage their party candidates to participate. 2) Candidates not responding were contacted by League members which did improve candidate participation. To date the response rate of candidates in contested races is as follows:

U.S. Senate – 62%; U.S. House – 57%; CO Senate – 80%; CO HOUSE – 54%; CU Regents – 50%; Dist. Atty - 86%; St. Board Ed. – 67%; and local races 67%.

LWVCO and several local Leagues used GOOGLE ADS to promote VOTE411 and the results have greatly increased our visibility. Since October 8 when we first started the ads, our ad has appeared 148,759 times when people used Google search for voter information. Out of this number, people clicked on our ad for additional information 6,401 times. This is a good return on our initial investment. Letters to the Editor, links to VOTE411 on League web pages and the use of Facebook and Twitter by LWVCO and local Leagues have also been used to promote our VOTE411.org site.

Has any of this made a difference? For the dates of October 16-23 Colorado had 14,483 'hits' on VOTE411.org, 6.76% of all 'hits' nationwide. Of that 14,483, 12,498 were first time visitors to the web site. With the VOTE411.org hits and the Google Ad hits, LWVCO's VOTE411.org is having an impact.

JUDICIAL MERIT SELECTION SYSTEM CELEBRATES 50 YEARS!

PLAN A PARTY IN YOUR COMMUNITY

Each day, hundreds of Coloradans enter our state's courthouses. They are plaintiffs, defendants, lawyers, witnesses, and jurors, and they all expect our courts to address each case and each party fairly and impartially. Every day, more than 300 Colorado state court judges enter the state's courthouses committed to fulfilling those expectations.

Until the mid-1960s, Colorado elected state court judges in partisan elections. The political parties' candidates solicited financial contributions from lawyers, law firms and others to mount their campaigns. When sitting judges completed their terms of office and sought re-election, they again solicited contributions. In 1966, Colorado's voters decided there was a better way. They amended the state constitution to end partisan elections and establish a merit-selection system instead.

To acknowledge how this system has advanced the needs of the state, maintains the integrity and independence of the judiciary and fosters the rule of law for all citizens, Governor Hickenlooper signed a State of Colorado Proclamation naming November 6th, 2016 – November 7th, 2017: *The 50th Anniversary of Colorado's Judicial Merit Selection System Year* (see page 9).

Over the coming year, take this perfect opportunity for your local League to educate the community about how we select judges. The event need not be ordinary. Try combining the presentation with a celebration of 'moneyfree' judicial elections. As an example, the Jefferson County League hosted a wine and dessert anniversary party entitled "Colorado Judges Can't Campaign! Learn Why While Sipping Wine".

Our Courts Colorado, a joint activity of the <u>Colorado</u> <u>Judicial Institute</u> and the <u>Colorado Bar Association</u>, provides nonpartisan information programs to adult audiences around the state to further public knowledge and understanding of the state and federal courts in Colorado free to charge. COLORADO LEAGUE DAY 2016

This year's Colorado League Day was held on Saturday, September 17, in Denver, and attended by 118 members. Leagues across the state were represented and discussions were lively and informative. This being an election year, a large segment of time was spent on the ballot issues (Gerry Cummins) and subsequently on the positions the state League has taken on many of these issues (Nancy Crow). Gerry Cummins again was lauded for her and her committee's work on both the Ballot Issues pamphlet and the generic ballot issues speech.

This year the state League took support positions on Amendment 69, State Health Care System; Amendment 70, State Minimum Wage; Amendment 72, Increase in Cigarette Tax; Proposition 107, Presidential Primary Elections; Proposition 108, Primary Elections; Amendment T, No Exception to Involuntary Servitude Prohibition; and Amendment U, Exempt Certain Possessory Interests From Property Taxes.

Other major speakers covered water, James Eklund, Director, Colorado Water Conservation Board, and poverty and income inequality, Claire Levy, Executive Director, Colorado Center on Law and Policy. Mr. Eklund spoke about the new Colorado Water Plan. One of the questions asked of him was to address how climate change is projected to affect Colorado's water. Ms. Levy presented many interesting charts and graphs that explain the effect of poverty and low income on citizens of Colorado. Some of these effects are felt not just by those in poverty but by all of us through the cost of government programs and the erosion of emphasis in this area.

Attendees at Colorado League Day also were brought up to date on administrative issues of concern to Leagues. Reports were made regarding VOTE411, Karen Connor; 501 Task Force, Marilyn Brown (see article on page 6 of this *Voter*); state League working with local Leagues, Sue Vaughan; and League Easy Web, Julie Leonard. Mary Ann Wilner, for the Boulder League, presented a case study of how members in that League have been working to pass a minimum wage in their jurisdiction.

If you didn't attend Colorado League Day this year, please consider attending next year. It's an excellent opportunity to keep up to date on a variety of issues of importance to the League and to Colorado.



WHEREAS, in Colorado's original constitution, adopted in 1876, the citizens of Colorado vested judicial power in the courts and the judges who preside over them; and

WHEREAS, courts of law safeguard the rights enshrined in the Bill of Rights, preserve the separation of powers, and uphold the state and federal constitutions; and

WHEREAS, Colorado's Constitution provides that courts of justice shall be open to every person, and that a speedy remedy afforded for every injury to person, property, character, and right, and that justice should be administered without sale, denial, or delay; and

WHEREAS, in 1966, after more than twenty years of effort by leaders of the bar, the citizens amended Colorado's constitution and created a system of judicial merit selection; and

WHEREAS, in Colorado, a lawyer aspiring to become a Colorado judge need not obtain the nomination of a political party, raise funds, campaign for office, or be elected in a partisan election; and

WHEREAS, no judge in Colorado may hold political office, make or receive campaign contributions, endorse political candidates, or participate in political campaigns; and

WHEREAS, judicial nominating commissions, comprised of both lawyers and lay persons of diverse political parties, review the qualifications of judicial candidates and forward nominees to the sitting governor for final selection; and


WHEREAS, judges remain accountable for their performance through citizen judicial performance commissions who make recommendations to the people before nonpartisan retention elections; and

WHEREAS, judges must comply with the Colorado Code of Judicial Conduct and are subject to the jurisdiction of the Colorado Commission on Judicial Discipline; and

WHEREAS, Colorado's system of merit selection has advanced the needs of the state, maintains the integrity and independence of the judiciary, and fosters the rule of law for all citizens;

Therefore, I, John W. Hickenlooper, Governor of the entire State of Colorado, do hereby proclaim, forever after, the period between November 8, 2016 and November 7, 2017, as the
