From Our President...

Leagues in Colorado are hard at work – having two national studies and a state study puts a lot on our plates. Thank you for rising to this task!

At the state League level, we're working in the following areas:

- **Building a Better Colorado** is a statewide coalition to engage Coloradans in a conversation about what our state should be within these topic areas: 1) How we create laws and amend our constitution; 2) How we elect our representatives; and 3) How we manage the state budget. Building a Better Colorado encourages citizen conversation and input at community summits during fall 2015 and will present an analysis of this input in December 2015. *LWVCO will be a Host for this process and will communicate regularly with local Leagues.*
- ColoradoCare Initiative 20 is collecting signatures for possible 2016 ballot inclusion. From their website: "ColoradoCare is a resident-owned, non-governmental health care financing system designed to ensure comprehensive, quality, accessible, lifetime health care for every Colorado resident. The benefit package would enhance the comprehensive health care services required by Medicaid and the Affordable Care Act. Premiums would be collected from Coloradans based on income, securing health care regardless of financial circumstance." <u>If enough signatures are collected for inclusion on the ballot, the LWVCO Board of Directors will vote regarding League support at our December 7, 2015 meeting.</u>

LWVCO's Board has two 2015-16 goals:

- Achieve LWVUS concurrence with the LWVCO Behavioral Health Position by June 2016 (as a LWVUS Recommended Program at the LWVUS 2016 Convention). The LWVCO Behavioral Health Study is underway; depending on consensus question responses, a draft Behavioral Health position will go to the LWVCO Board December 7. If this position is approved, LWVCO will propose adoption through concurrence at the LWVUS Convention and will lobby all state Leagues to make this happen.
- In partnership with local Leagues, develop and implement a plan that increases League's impact and visibility statewide. LWVCO has strengthened its Board Liaison to Local Leagues job description and has formulated a local League support plan called LINK - League Information, Networking and Know-how. LWVCO Board liaisons will contact all local Leagues three times a year to provide information about LWVCO's work and to listen to, and try to address, local League questions and needs.

All local Leagues are an integral and important part of the efforts noted above and LWVCO will continue to communicate and to report progress in these areas.

LWVCO SPONSORS COLORADO CHANNEL

If you've watched the Colorado Senate or House of Representatives in session without traveling to the Capitol itself, it's courtesy of the Colorado Channel. On Comcast cable, the chambers alternate day by day, but you can choose which one you want to watch streaming on the web at <u>www.coloradochannel.net</u>. If watching live isn't convenient, you can view archived recordings of past sessions.

On the Colorado Channel website you can also listen to essentially all legislative committee hearings, as they're happening or after they're posted to the archive, usually within 24 hours. The LWVCO Legislative Action Committee makes much use of this service, which means that League members from all over Colorado can participate.

In recognition of its importance to open government in the state, LWVCO has recently become a sponsor of the Colorado Channel. Our logo and name on the *Sponsors* page of the website will also increase League visibility. In the Denver area, Colorado Channel is channel 165 on Comcast cable; check with your local Comcast cable listing to see if you can get it on your TV.

When the legislature isn't in session, we recommend looking through the educational videos available on the *Additional Content* page of the website. Here you can find the State of the State address, the State of the Judiciary address, *How a Bill Becomes a Law in Colorado, The Colorado State Amphibian: The Western Tiger Salamander,* and more.

LEAGUE DAY 2015

Saturday, September 19, found 125 League members convened for a daylong program of gathering information and networking. The morning program focused on voting and elections, the afternoon on current studies, and ending with a presentation on polling. The take-home messages from each speaker are as follows:

Suzanne Staiert, Deputy Secretary of State – Successful innovations in Colorado voting are same day registration, all mail-in ballots, and on-line registration. Challenges include establishing a uniform voting system (at present Colorado has nine systems that vary county by county).

Gerry Cummins, LWVCO VP Voter Service – Proposition BB is the only ballot issue for the fall 2015 election. The major provisions of this proposition allow the state to keep tax revenue from the sale of marijuana, permitting the state to spend this revenue to provide \$40 million for public school construction. If Prop BB fails, refunds will go to retail marijuana cultivation facilities, to retail marijuana purchasers, and to Colorado taxpayers who file.

Nancy Crow, LWVCO VP Program – The LWVCO supports Proposition BB.

Cecilia Ruffing and Celeste Landry, LWV Boulder County – Through a participatory demonstration, we learned the mechanics of four voting methods – plurality voting, approval voting, range (or score) voting, and instant runoff voting.

Clay Shentrup, Co-founder of The Center for Election Science – Some benefits of preferential voting methods are as follows: remove the vote-for-one restriction, broadly supported candidates are favored, and voters can always include their honest favorite.

Nancy Crow, LWVCO VP Program – There are a number of electoral reforms that have been proposed. The LWV supports some, but has no position on many others.

Barbara Mattison, LWVCO President and Chair of the Behavioral Health Study Committee – Barbara drew our attention to the new study materials in the updated LWVCO Behavioral Health Task Force Report that will inform the consensus process.

Toni Larson*, VP LWVUS - Comprehensive materials for the two LWVUS studies - Money in Politics and Amending the Constitution - are easily accessible on the LWVUS website. On the home page, select League Management. On the next page under Our Work there is a pull down menu that will link you to materials for both studies.

Bonnie Seals, LWV Estes Park – Important decisions are made in politics based on polling. Polls in the 21^{st} century face challenges their 20^{th} century counterparts did not: technology, demographics, and mail-in ballots.

LWVCO SIGNS ONTO LWVUS LETTER TO EPA

LWVCO is proud to have joined 35 other state Leagues in signing on to LWVUS President Elisabeth McNamara's written comments to the EPA's Science Advisory Board (SAB) requesting revision of the current draft of a research report called *Assessment of Potential Impacts of Hydraulic Fracturing for Oil and Gas on Drinking Water Resources*. The LWV believes that the draft does not adequately represent the research funded by Congress in 2010.

PROGRAM PLANNING 2016

Early in each year (January or February) local Leagues participate in LWV 'program' planning by making recommendations concerning program issues. 'Program' in League lingo means the sum total of all our local, state, and national positions on issues and the grass roots process of studying issues leading to those positions. This is how the League remains a grassroots organization. Because 2016 is an even numbered year with our biennial convention this year (June 16-19 in Washington, D.C.), local Leagues will consider the national program as well as their own local program.

I. LWVUS Program

This is the opportunity for local Leagues to review LWVUS positions, propose a new study, identify a position for review, support concurrence with the position of another League, or recommend that a position be dropped.

Local Leagues will receive requests from other Leagues, either local or state, to support a particular proposed program item at the national level. Local Leagues should consider these requests and make a decision whether to support asking the LWVUS Board to recommend the item at the national convention in June 2016, and/or to support the item on the floor of the convention.

This year, assuming we reach consensus here in Colorado, the LWVCO Board will request that local and state Leagues throughout the country recommend concurrence with the LWVCO Behavioral Health Position that is being developed through this study and consensus process. (The concurrence process requires an up or down vote at convention, with no allowance for wording changes.)

The LWVCO requests that local Leagues in Colorado support this request.

II. Local Program

Similarly, this is an opportunity for local Leagues to review their own positions, propose new studies, identify a position for review, support concurrence with the position of another League, or recommend a position be dropped. Suggested program changes or additions would be addressed at the local League's annual meeting.

LWVCO Board members and MLD coaches have taken significant strides to coordinate how they provide support to local Leagues. There is significant support available to local leaders and major interest in your success! Let us clarify:

At its August retreat, the state board set a goal to partner with local Leagues with the purpose of increasing League's impact and visibility statewide. Subsequently the board established a Local League Support Committee, which in turn developed a strategy called League Information, Networking and Know-how (LINK). State board members are assigned as liaisons to specific local Leagues, and they will be contacting all Leagues approximately three times per year to share information about state League activities and to gather feedback related to your relationship with the state League.

Those local Leagues enrolled in the Membership and Leadership Development program (MLD), receive monthly calls from their coaches.
